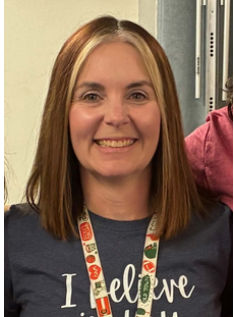
### Jenny Weindel, NORTHWEST EDUC ASSN

### **Brendan Kearns, ST CHARLES E A**



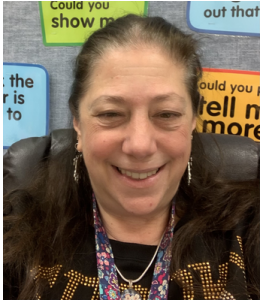

### **Amy Metz, RITENOUR NEA**



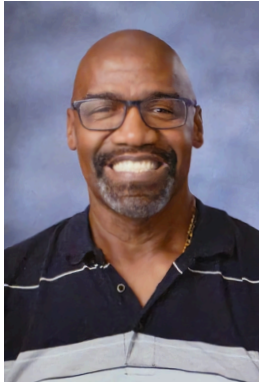
