



# Princess Moss Vice President National Education Association

Princess Moss, an elementary school music teacher from Louisa County, Va., is the vice president of the National Education Association, the nation's largest professional organization.

A champion of children and public education at the local, state, and national levels, Moss served as secretary-treasurer from 2014 through 2020. Prior to this, she distinguished herself with two terms on the NEA Executive Committee, where she served on the Elementary and Secondary Education (ESEA) Advisory Committee, steering the Association's strategy for the law's pending reauthorization, and the Dropout Prevention Advisory Committee, helping develop relevant tools for NEA members. Under her direction as president, the 62,000-member Virginia Education Association increased its membership and advocated successfully for greater investment in public education at the state and local levels. She also served as VEA Vice President and on the Board of Directors for NEA and VEA for over 10 years.

The daughter of two school bus drivers, Moss earned her bachelor's degree in music education from the University of Mary Washington, and received the university's Distinguished Alumnus Award in 2006. She also earned a master's degree in elementary and secondary administration and supervision from the University of Virginia.



#### **MINUTES**

Pres. Phil Murray called the Representative Assembly to order at 9:37 a.m.

#### **INTRODUCTIONS**

Pres. Murray introduced the individuals seated at the head table: Rebeka McIntosh, MNEA Vice President; Paul Guess, NEA Director; Andy Slaughter, NEA Director; Becky Pringle, NEA President; Daniel Bryar, Parliamentarian; DeeAnn Aull, MNEA Executive Director; and Roxane Bly, Governance Secretary.

#### NATIVE LANDS ACKNOWLEDGEMENT

Pres. Murray recognized Dr. Alexander Tai (Columbia MNEA), and he delivered the Native Lands Acknowledgement.

#### STANDARDS OF CONDUCT

Dr. Alexander Tai (Columbia MNEA) reviewed the NEA Standards of Conduct.

<u>NATIONAL ANTHEM</u> – video presentation.

#### PLEDGE OF ALLEGIANCE

Pres. Murray led the Pledge of Allegiance.

#### ADOPTION OF THE CREDENTIALS/BYLAW COMPLIANCE REPORT

Credentials Committee Chair Donna Rudroff (MNEA Retired) delivered the following credentials report:

#### **ADOPTION OF STANDING RULES**

Pres. Murray stated that being no objection, the rules would not be read. There was no debate and no amendments. The standing rules were adopted unanimously by a show of cards.

#### **COMMON MOTIONS IN MEETINGS**

Pres. Murray explained that the Common Motions in Meetings were included in the packet and advised that if delegates had questions, they could visit with the parliamentarian, Daniel Bryar, who is also the MNEA Associate General Counsel.

#### **ADOPTION OF AGENDA**

Pres. Murray stated that the agenda would not be read. There were no corrections or additions to the agenda. The agenda was adopted unanimously by a show of cards.

#### RECOGNITION

Pres. Murray recognized all building representatives, local executive committee members, local presidents, the members of the MNEA board of directors, NEA ESP At-Large Directors Dennis Tabb and Carmen Hill, all MNEA Retired delegates, Higher Ed delegates, ESP delegates, and the MNEA staff.

#### **IN MEMORIUM**

The following individuals were commemorated: Lillian Boly, Riverview Gardens NEA; Cynthia Chapel, Lincoln University MNEA; Ellis Shaw, Ferguson Florissant NEA; Fauntroy Todd, Normandy NEA; and Constance Inman, Park Hill NEA.

#### **REPORTS**

#### President's Report – MNEA President, Phil Murray

Pres. Murray recognized several individuals in the room: Bobbie Bollman, Peggy Cochran, and Rob Meyers, a founding member of MNEA. He described leadership as a journey from the moment his gavel was given to him by former MNEA President Charles Smith. He described the challenges and victories he has experienced during his leadership journey and key moments as a leader: the 2008 financial crisis, Janus v. AFSCME, the 2016 election, No Child Left Behind, and the COVID-19 pandemic. He introduced NEA President Becky Pringle and how it felt when he joined the NEA Board of Directors—the feeling of his voice in room and the stature of Becky listening.

#### **REMARKS**

#### **Becky Pringle, NEA President**

NEA President Becky Pringle thanked the delegates for their phenomenal work and fearless leadership. She congratulated them on the legacy of work to build the Association and encouraged them to stand proud. She stressed the importance of coming together to share knowledge, experience, and wisdom in this time full of challenges and obstacles. Her passion for the rights of children and educators was palpable when she said, "All these schemes are designed to disrespect those of us who have dedicated our lives to educating the children of this country....the shortage is in professional pay for our educators. The shortage is in the respect for the people who have studied and dedicated their lives to making the best decisions for our children." She concluded her remarks by pointing out that elections everywhere matter to all of us every day and encouraged delegates to reach out to one another as leaders in this union and this democratic society.

#### **INFORMATION**

Pres. Murray recognized Human Rights Committee Chair Jo Wanda Bozeman (MNEA Retired) who provided an update on the HOPE Fund and Rock the Socks.

Pres. Murray recognized Women's Issues Committee Chair Joyce Bluett (MNEA Retired) who stressed the implications of "period poverty" and urged delegates to donate personal hygiene products and supplies for distribution to local schools.

Pres. Murray recognized Julia Todd (MNEA Retired) who provided an update on the PAC Table. She thanked Mary Varner (MNEA Retired) and Kitty Thiess (MNEA Retired) for helping her with the PAC Table. She also thanked MNEA Political Director Liz Zerr and the MNEA UniServ Directors for their help.

Moira McCracken (Parkway NEA) requested and was granted a point of personal privilege and informed the Assembly that Parkway NEA donated \$1,500 to the HOPE Fund.

Pres. Murray showed the Assembly a copy of the MNEA 50<sup>th</sup> Anniversary Book. He explained that the 50<sup>th</sup> anniversary celebration participants would receive their copies first and then copies would be distributed to all delegates.

#### **REPORTS**

#### **DeeAnn Aull, Executive Director**

MNEA Executive Director, DeeAnn Aull presented the "State of the Association" and highlighted the organization's progress against its strategic priorities:

- Recruiting and retaining members.
- Building strong locals.
- Using effective internal and external communication.
- Increasing influence and advocacy.

She reminded delegates that the decisions they make today regarding the resolutions and budget have occurred each year for 50 years. "Those decisions have driven what we are and what we've become. What you do today determines our future," she said. DeeAnn concluded her remarks by saying, "We need the fighting spirit and will to win. You've demonstrated that over and over, and this year you need to celebrate. We continue to challenge ourselves to do better and to be something better."

#### **INFORMATION**

Pres. Murray recognized the efforts of Springfield NEA President Laura Mullins and explained that she is working on nine contracts. He praised the election night efforts of MNEA Political Director Liz Zerr whose hard work paid off with MNEA members winning 83% of elections where a recommendation was made. He highlighted Fort Zumwalt EA and their efforts in St. Charles County which resulted in winning six out of the seven seats.

Pres. Murray introduced Rebecca Stumpf with California Casualty who congratulated the Association on celebrating 50 years of strong advocacy for education professionals across the

state. She noted that California Casualty has been alongside the Association for half that time. Rebecca encouraged delegates to apply for the <u>Music & Arts grant</u>.

Pres. Murray recognized Jo Wanda Bozeman (MNEA Retired) who serves as president of the Heritage House Board of Trustees. Jo Wanda provided a brief overview of the non-profit organization that provides affordable housing for retired teachers.

Pres. Murray advised the assembly that members of MNEA serve on the Heritage House Board of Trustees and an election would be held in the afternoon for three open seats. He added that the Assembly would discuss the MNEA Resolutions and proposed 23-24 budget in the afternoon and make nominations for vacant seats on the MNEA board of directors.

Pres. Murray recessed the Representative Assembly for lunch at 11:29 a.m.

The Representative Assembly resumed at 1:16 p.m.

#### APPROVAL OF FALL RA MINUTES, November 19, 2022

Pres. Murray presented the November 19, 2022, Fall RA minutes. The MNEA Board of Directors tentatively approved the minutes at the February 2023 board meeting. There were no questions or amendments to the minutes. As there were none, Pres. Murray called for a vote to approve the minutes as printed. The minutes were approved by a show of voting cards.

#### **REPORTS**

Pres. Murray introduced Jason Steliga (Park Hill NEA), who serves as chair of the PSRS/PEERS Board of Trustees. He provided an overview of the PSRS/PEERS System of Missouri and explained that it is the 44<sup>th</sup> largest pension fund in the country and the 96<sup>th</sup> largest investor in the world. He stated that the pension is funded at 85% and paid out \$3.5 billion in promised benefits to retirees.

Pres. Murray recognized Teaching & Learning Committee Chair Tresina Alvested (Odessa MNEA), who explained that the Missouri DESE Blue Ribbon Commission is trying to obtain input regarding teacher retention and recruitment. She urged delegates to participate in a survey to provide input to the commission.

#### **BUSINESS ITEMS**

**MNEA Resolutions.** Resolutions Committee Board Liaison Andy Slaughter (Meramec Valley NEA) presented the proposed amendments to the MNEA Resolutions:

A-5 Federally and State-Mandated Choice/Parental Options – new language stressing the importance of local control.

A-15 Elected Governing Boards – new language to stress local control.

A-19 Assisting Schools/Districts in Academic Crisis – new language that establishes parameters for assistance and a formal appeal process.

New Resolution A-23 District Consolidation/Deconsolidation – new resolution that establishes parameters for proposals and process for district consolidation/deconsolidation.

- B-15 Diversity of Educational Curriculum added "current" to read, "The teaching of <u>current</u> and historical truths…"
- B-31 Library/Media Programs strike "be empowered to" to read, "...library media centers should include culturally responsive materials..."
- C-19 Transportation new language to read, "<u>Districts should not be required to transport students to other school districts except in the case of special needs or programs.</u>"
- E-4 Academic and Professional Freedoms new language to read, "...present and discuss divergent points of view <u>under conditions permitting independence of thought and expression</u>."

**23-24 Missouri NEA Program Budget.** Vice Pres. McIntosh provided an overview of the budget development process and proposed budget.

Pres. Murray recognized Greg Meyer (MNEA Retired) who raised several questions about the proposed 23-24 budget:

- What is the reason for the reduction in compensation for the president and vice president? Vice Pres. McIntosh explained that previously, the president and vice president did not participate in the MNEA retirement system. Subsequently, they were able to participate, and the increased amount in the previous year was to "catch up" their contributions.
- What is the reason for the increase in miscellaneous employee benefit costs from \$5,681 to \$16,500? This is a typo, and the actual 21-22 amount is \$15,681.
- Why did MNEA Organizing increase from \$3,249 to \$50,000? The 21-22 line item included only NEA grant funds, and the proposed 23-24 line item includes MNEA expenditures.

**MNEA Board of Directors Elections.** Pres. Murray stated that there are four seats open, and each seat is for an unexpired 2-year term.

Governance District 2. Amanda Perschall (Lebanon NEA) nominated herself. Pres. Murray declared Amanda Perschall elected.

Governance District 3. No nominations were made, and Pres. Murray will appoint someone to serve as director.

Governance District 6. Dr. Alexander Tai (Columbia MNEA) nominated Scott Dean (Columbia MNEA). Pres. Murray declared Scott Dean elected.

Governance District 7. Kelli Ward (Ferguson Florissant NEA) nominated Dennis Tabb (Ferguson Florissant NEA). Pres. Murray declared Dennis Tabb elected.

#### **INFORMATION**

Pres. Murray recognized MNEA Retired Vice President Georgia Brady who encouraged delegates to join MNEA pre-retired. She explained the benefits of a seamless transition to MNEA Retired with no dues increases.

Pres. Murray recognized Julia Todd (MNEA Retired) who provided an update on the PAC Table.

Pres. Murray recognized Human Rights Committee Chair Jo Wanda Bozeman (MNEA Retired) who provided an update on the HOPE Fund.

Pres. Murray recognized Women's Issues Committee Chair Joyce Bluett (MNEA Retired) who thanked delegates for their donations of personal hygiene products and supplies.

#### **BUSINESS ITEMS**

**NEA Director Election.** Pres. Murray announced the re-election of Andy Slaughter to a second 3-year term as NEA Director.

Phylliss Hayden (Ferguson Florissant NEA) nominated Chuck Howard (Special District NEA).

Diane Livingston (MNEA Retired) nominated Wanda Malin (MNEA Retired). Pres. Murray declared Diane Livingston, Chuck Howard, and Wanda Malin elected to the Heritage House Board of Trustees.

#### **INFORMATION**

Pres. Murray recognized Julia Todd (MNEA Retired) who provided an update on the PAC Table.

Dr. Alexander Tai (Columbia MNEA) requested and was granted a point of personal privilege. He encouraged delegates to visit the LGBTQ table.

Judy Hinsley (MNEA Retired) requested and was granted a point of personal privilege. She said that if delegates would donate their unused toiletries from their hotel rooms, she would collect them to donate to <u>Project Backpack</u> in St. Louis.

Pres. Murray advised that only Governance District 4 would meet in the morning.

Pres. Murray recessed the Representative Assembly at 2:37 p.m.



Pres. Murray recognized Human Rights Committee Chair Jo Wanda Bozeman (MNEA Retired) who provided a fundraising update.

#### **BUSINESS ITEMS**

Pres. Murray presented the Lorna Bottger Award for Individual Excellence in Political Action to Dorothy Walk (MNEA Retired).

Pres. Murray presented the Soar with the Eagles Award to Laura Mullins (Springfield NEA).

Pres. Murray presented the 2023 Horace Mann Friend of Education Award to MNEA Executive Director DeeAnn Aull. When accepting the award, DeeAnn remarked, "No one has successes alone. Together, we have truly changed public education."

#### **REPORTS**

#### **NEA Directors Report – Paul Guess and Andy Slaughter**

NEA Directors Paul Guess and Andy Slaughter represent Missouri on the national board of directors. They described the many activities they have participated in and the policy initiatives they are working on:

- Social Security Fairness Act to eliminate the Government Pension Offset and Windfall Elimination Provision that deprives educators and other public retirees of their earned benefits.
- Sub-committee related to student technology and will be share results shortly. Good data to use to eliminate issues related to technology.
- Attended the ESP Conference in Seattle where Katheryn Selby (Special Ed Employees) delivered a presentation on tools and knowledge needed to teach self-advocacy skills to students
- Superweek visits to the Missouri congressional delegation.

The directors announced that the NEA RA will be held in Kansas City, MO in 2029.

### Government Relations Update – MNEA Legislative Director Otto Fajen and MNEA Political Director Liz Zerr

MNEA Legislative Director Otto Fajen provided an overview of the legislative landscape during the current session. Priorities include local control and accountability. Returning issues include parents' rights and CRT bans, open enrollment, tax credit vouchers, charter schools and funding/tax cuts. Otto encouraged delegates to stay involved by participating in Capital Action Days, engaging with legislators to discuss MNEA issues, and following legislative updates.

MNEA Political Director Liz Zerr provided an overview of campaigns and elections stressing the importance of being involved in politics to improve the daily lives of members and students. She explained that through hard work, MNEA can win in hard places and showed how MNEA members won 83% of elections where a recommendation was made. She described how success was due to direct voter contact and an expanded digital program. Liz encouraged delegates to begin planning now for 2024.
