

## Terry's Table Talk

May 1 was Capitol Action Day for the MNEA Retirees. We had nineteen members in attendance at the Capitol. Otto Fagan and Liz Zerr had a Capitol Action Day schedule. The priority bill was SB 727, which expands the existing tax credit voucher enacted in 2021. All the retirees were asked to swing by the Governor's office to let him know that we appreciate many of the investments in public education that the bill provides, but we were asking him to veto bill SB 727 because the bill authorizes the establishment of school vouchers and charter schools. Since the Governor signed bill SB 727, MNEA and MNEA-Retired are concerned that future funding by the state will diminish monies to our public school districts.



A group of the retirees visited the Democrat that voted in favor of SB 727. Her reasoning was flawed. She felt that the public school in her district was not meeting the needs of the children. Instead of talking to the superintendent and school board about ways to improve the school district, she decided that the residents should be allowed to send their children to a charter school or be given vouchers to attend another school.

We visited two of our former teachers who are representatives of the House: Kathy Steinhoff and Paula Brown. As Paula Brown retires, we hope that Connie Steinmetz will be elected to take her place.

National News: General Counsel Alice O'Brien gave an update on the harmful effects of our current Supreme Court with adverse decisions to unions, affirmative action, OSHA regulations, allowing businesses to discriminate against LGBTQ+ for religious objections, stripped reproductive rights, hamstrung common sense gun regulations, and blocked \$400 billion for debt release.



It was an exciting day for MNEA-R members who went to Capitol Action Day in Jefferson City. The day was spent talking with legislators about public education and retirement issues, as well as meeting with members of the Aspiring Educators program.

One MNEA-R member, Connie Steinmetz, was especially excited because she hopes to join the legislators next year as the representative from House District 87. The current representative, MNEA-R member Paula Brown, is not running for re-election due to redistricting, and she tapped Connie to run as her replacement. Connie jumped at the opportunity and has been busy hitting the campaign trail since November. Connie taught in Hazelwood for 37 years and finished her career by serving 6 years as president of Hazelwood NEA. She has been endorsed by Missouri NEA because of her strong commitment to public education, working families and unions, and safe communities. Connie doesn't have a primary opponent in August, but she will face an opponent in the November general election and is working hard to raise money for her campaign. Please support Connie and her


campaign by going to <u>conniesteinmetz.org</u>—we need the 87<sup>th</sup> to stay pro-public education with one of our members in the seat!
