


Terry's Table Talk

In the meantime, it is time for you to make a decision to be a candidate for one of MNEA-Retired positions designated below! It is also time for you to register for the virtual ANNUAL meeting!

If you are an MNEA-Retired member and would like to run for office or delegate, you must declare your candidacy **by March 15, 2021**. Click here to declare your candidacy: <u>www.mnea.org/retired</u>. You must complete the online declaration form by <u>March 15</u>. When a candidate declares candidacy, they will be able upload a photo and 100 words about themselves and why they should be elected to serve!

The offices of President, Vice President, Historian, Budget, Board of Director (if you have served 2 terms on the BOD as a non-retiree, you are **ineligible** to run again), four Executive Council Membersat-Large are up for election. The delegates to the **virtual** NEA-Retired and NEA Representative Assemblies (summer, 2021) and delegates to the MNEA Representative Assemblies (fall 2021, 2022 and spring 2022, 2023) are up for election. The election will take place **online** and will open on **April 7 and close at 5 PM on April 21, 2021.** MNEA-Retired will have a **virtual** Annual Business Meeting on **April 23, 2021**. To register for the Annual Meeting, you must have a valid email address. MNEA-Retired members in good standing will be considered delegates and receive an electronic ballot to vote in the election for the offices above. **To register, click on** <u>www.mnea.org/retired</u>.

Additional information will be available for those who register. Upon registering, you will receive an email receipt with links for the three sessions that will constitute the virtual 2021 MNEA-Retired Annual Meeting. Two of the three sessions will be to hear the speeches of the candidates. The third session will be MNEA-Retired virtual Annual Meeting Main Business Session. PLEASE

those years, the two members who worked most closely with Greg were MNEA Presidents, Donna Collins, and Chris Guinther. Their personal thoughts about Greg are captured as follows:

Donna – "Greg was the kindest and most passionate person I've ever known. He loved his kids and his partner, Chris, more than words can adequately express. Greg worked tirelessly to protect public education, advocated for justice, and promoted LGBTQ equality. He knew the best way to promote the causes he believed in was through political action."

Chris – "Not only was Greg my mentor in leadership skills, but more than that, he was a good friend and taught me much about life, living well, and love. During our hundreds of hours of "windshield time" we shared laughter and the stories of our lives. One of my greatest joys was knowing the wonderful life he had with Christopher, and one of my greatest sorrows is losing him as a friend."

Greg Jung's association support did not end with retirement. Although he moved to Florida where his life moved in a new direction, he remained loyal and active in the association he loved. Along with Martha Karlovetz, he helped organize the Suncoast NEA-Retired. Greg returned to Missouri for a number of MNEA-Retired Annual Meetings, and he never failed to send generous PAC donations to our MNEA-Retired RA delegates.
