


Terry's Table Talk

Political Action Information

DeeAnn Aull spoke at our Executive Council (E.C.) meeting on Thursday, September 15, to explain PAC contributions from MNEA-Retirees and MNEA members.

The members of the Executive Council were told that the money that delegates give to the MNEA PAC Auctions at the MNEA Representative Assembly in November and April go to TISPE fund (Taxpayers in Support of Public Education) and/or ESPE fund (Educators in Support of Public Education). These contributions help elect both democrats and republicans in the Missouri State Legislature who support public education.

The money delegates give to the **MNEA-Retired PAC Auction at the Annual Meeting** may be designated to our state or national* organizations (at the discretion of the Executive Council). However, in most years we allow the members in attendance to give to either the state or national organization, or if they so desire, both organizations. The **MNEA-Retired Auction in November** (whether it is in St. Louis, Kansas City or Branson) goes to the C.H.E.E.R. fund only.

MNEA PAC supports state retirement issues, especially our pensions and fights any state issues that adversely affect public education and our retirees. The money delegates give to the * **NEA-Retired PAC Auction** supports and retirement issues, especially GPO/WEP. The money delegates give to **NEA PAC** helps elect national candidates that support public education and fights any issues that adversely affects public education and our retirees, like GPO/WEP.

The Executive Council were told why our two retired elected PAC members, Nancy Copenhaver and Greg Meyer, must share one vote (each getting one-half a vote). We may give more money than any other schoolteacher group, but the votes are based on the number of contributors that are given to MNEA PAC. We need more of our retirees to give small contributions (\$5 or \$10) to the MNEA PAC. Remember that the most votes any local group is allowed is two. It would be great if each of our delegates have one vote each.

MNEA stopped having the *PAC Awards* to yearly honorees who gave contributions to MNEA PAC in 2018 because of a law that changed the way members contribute and the amounts members contributed changed drastically


Focus Points . . .
