With the COVID-19 pandemic raging, school districts are desperate for substitute teachers. The State Board of Education initiated a temporary policy for hiring substitutes that greatly diminished the education requirements, whereas, a substitute was not even required to have a high school diploma. Missouri NEA stepped in to urge the SBOE not to make this change permanent, making sure that qualifications for those teaching Missouri students were not sub-standard for years to come. MNEA Legislative Director Otto Fajen attends the Board meetings of the Public School Retirement/Public **Education Employees** System. Read the report from the Oct. 26, 2020 meeting. The report summarizes the investment performance, system operations, audit, valuation, budget and capital projects. The twoyear cumulative CPI-U total is 2.30% (FY2019 +1.65% plus FY2020+.65%), which meets the threshold to raise the COLA for pension payments. The Board voted unanimously to grant a COLA increase beginning January 2021.
